CALL FOR BIDS

in the open tendering public procurement procedure, procurement number 1.1.5.

1. **Name, address and website of the Contracting Authority:** Ministry of Agriculture, Forestry and Water Management – Republic Water Directorate, Bulevar umetnosti 2A, www.rdvode.gov.rs.

2. **Type of Contracting Authority:** Public administration body.

3. **Type of public procurement procedure:** Open tendering.

4. **Type of supplies:** Goods

5. **Description of the supplies, name and designation according to the Common Procurement Vocabulary:** Procurement of construction of special-purpose ship – icebreaker, 34510000-5 Ships

6. **Economic classification:** 512 – Machines and equipment

7. **Contract award criterion:** most economically advantageous tender.

Elements of the contract award criterion are as follows:

8. **Manner of obtaining the Bidding Dossier and/or website where the Bidding Dossier is available for downloading:** The Bidding Dossier is available for downloading on the Public Procurement Portal and on the Contracting Authority's website at www.rdvode.gov.rs.

9. **Manner and time limit for submission of bids:** Bids may be delivered in person or sent by mail to the address of the Contracting Authority: Ministry of Agriculture, Forestry and Water Management – Republic Water Directorate, Bulevar umetnosti 2A, on weekdays from 8:00 AM to 3:00 PM, and must be placed in a sealed envelope marked "**Public procurement of construction of a special-purpose ship – icebreaker – DO NOT OPEN**". The bidder must state its name, address, phone and contact person on the envelope.

The final date for the submission of bids is 15 April 2020 by 10:00 AM.

10. **Place, time and manner of opening of bids:** Public opening of bids shall take place on the final date for the submission of bids, on 15 April 2020, starting at 10:15 AM, on the premises of the Ministry of Agriculture, Forestry and Water Management – Republic Water Directorate, Bulevar umetnosti 2A, office 301.

The bid opening procedure will be carried out by a Committee formed by a decision passed by the Contracting Authority.

11. **Conditions under which representatives of bidders can participate in the procedure of opening of bids:** Bidders' representatives who attend the public opening of bids must present to the Committee a registered and certified power of attorney for participation on the bid opening procedure for the public procurement, otherwise they shall be present as members of

the public and shall not be allowed to actively participate in the procedure (by signing the minutes, raising objections etc.).

12. **Time limit for the passing of a decisions:** The Contracting Authority shall pass a decision on the award of the public procurement contract within 25 days of the date of public opening of bids.
